

GRAVEL MARATHON VALLE SPLUGA "FAMILY" is a leisure bicycle ride for children and families that takes place mainly on the Valchiavenna Bike Path.

All participants in Gravel Marathon Vallespluga Family Chiavenna (SO) are required to read the following Regulations carefully before registering.

### **ART.1 – GENERAL INFORMATION ABOUT THE EVENT**

Gravel Marathon Valle Spluga Family will take place on Sunday 17 September 2023 in Chiavenna (SO) Italy. Gravel Marathon Valle Spluga Family is a leisure bicycle ride that takes place on a completely asphalted, charming and scenic route, surrounded by greenery, to cycle amidst villages and cultivated fields in the lower valley.

#### **ART.2 – BICYCLES**

Gravel Marathon Valle Spluga Family is a leisure bicycle ride in which you can participate with road, cyclocross, gravel, MTB, and hybrid leisure bicycles; electric bicycles are also permitted.

### ART.3 - ROUTE

One single route: "Valchiavenna Bike Path", 31.2 km of length, 140 m elevation gain.

### ART.4 – START

The start will be at 10:00 a.m.

The route will be signposted. In addition, there will be a guide leading the way and a guide at the end of the Event.

### ART.5 - PARTICIPATION REQUIREMENTS AND SPORTS MEMBERSHIP

Gravel Marathon Valle Spluga Family is open to everyone aged 6 years and over of both sexes.

All those who register for the Gravel Marathon Valle Spluga Family will receive a daily insurance policy.

Minors aged between 6 and 18 may only participate if authorised by their parents or guardians. The authorisation form is available on the website <a href="www.gravelspluga.it">www.gravelspluga.it</a>, Family section. The form must be downloaded, printed out and filled in, and must be handed in upon collecting the technical envelope.

## **ART. 6 - PARTICIPATION**

The use of an approved hard helmet and keeping it fastened throughout the event is mandatory. Cyclists are required to comply with the Highway Code.

## ART. 7 - FAMILY REGISTRATION PROCEDURES AND COSTS

Registrations can be made directly from the website <u>www.gravelspluga.it</u> or at the infopoints in Chiavenna, Campodolcino and Madesimo.



Registration opens at 09:00 a.m. (CET) on 30 April 2023 with the following fees and closing dates:

- STANDARD Registration: open to all for € 25.00 from 1 March 2023 until 17 september 2023;
- KIDS Registration open to all for €10 from 1 March 2023 to 17 September 2023 reserved for children aged 6 to 13.

The registration fee includes:

- RACE PACK with free gadgets and souvenir items from the Event;
- FRONT RACE NUMBER to be affixed on the bicycle handlebars;
- ROAD BOOK on which to get control stamps;
- Typical Emilian REFRESHMENT at Lago di Mezzola
- 5 € discount on the purchase of the shirt
- · Pizzocheri party

# ART. 8 - COLLECTION OF THE TECHNICAL ENVELOPE & RACE PACK

At Gravel Marathon Valle Spluga Family TECHNICAL ENVELOPES & RACE PACKS will be handed out before the Event at the following schedule:

- Saturday 16 September 2023 from 2:00 p.m. to 8:00 p.m.;
- Sunday 17 September 2023 from 08:00 to 09:30 a.m.

To collect the TECHNICAL ENVELOPE and RACE PACK it will be necessary to present:

- printout of registration page;
- · valid ID document;

### ART. 9 - COMPLIANCE WITH THE HIGHWAY CODE

Gravel Marathon Valle Spluga Family is a LEISURE CYCLING RIDE on asphalt and dirt roads. The entire route will be always open to traffic, therefore it is mandatory for all participants to respect the Highway Code. It is suggested to bring a repair kit for breakdowns and punctures.

# ART. 10 - TIME LIMIT AND MEDICAL ASSISTANCE

The time limit to complete the leisure cycling ride is 3:00 p.m.

No medical assistance is provided, except for a medical S.O.S. for emergencies. No mechanical assistance is provided. No assistance by private vehicles following the event is allowed.

## ART. 11 - REFRESHMENT STATION AND CONTROLS

Along the route there is a refreshment station with beverages, sweet and savoury food in authentic Vallespluga style.

Refreshment station and control opening and closing:

- CHIAVENNA: CONTROL opening from 09:15 to 09:45 a.m.
- REFRESHMENT STATION: opening at 11:00 a.m., closing at 2:00 p.m.
- CHIAVENNA: CONTROL AT THE FINISH closing at 3:00 p.m.

## **ART. 12 - CANCELLATION OF PARTICIPATION**



Should a registered participant be unable to take part in the Gravel Marathon Valle Spluga Family, the participation fee will not be refunded, and the race packet will not be sent.

Within 30 days before the date of the event it is possible to give notice of cancellation by sending an email to info@gravelspluga.it.

The organisation reserves the right to evaluate, at its sole discretion, the communications received if motivated by "objective impossibility to participate due to injury" documented by clinical reports.

Clinical documentation will be treated in compliance with the current privacy regulations.

In cases recognised by the organisation, the participation fee alone will be considered valid for registration for the following year's edition.

The entry fee held valid for the following year is nominal and non-transferable to third parties and will only be valid for the year following the withdrawal. In the event of further non-participation, the fee will be considered lost.

#### ART. 13 - CONTROL STAMPS

The control stamps are the only evidence of the completion of the route and will be stamped in the road book, along the route and at the finish line.

### ART. 14 - AWARDS

Participants who complete the Gravel Marathon Valle Spluga Family will receive a prize at the finish line.

### ART. 15 - MEDICAL ASSISTANCE

Medical assistance will include ambulances with doctors and medical personnel.

### **ART. 16 - MECHANICAL ASSISTANCE**

Assistance of any kind by private vehicles following the race is strictly prohibited. The organisation guarantees mechanical assistance at the refreshment station.

### **ART. 17 - COMPLAINTS AND INFORMATION**

Any complaints must be submitted to the organisation exclusively by email info@gravelspluga.it within 10 days of the publication of the list of finishers.

## **ART. 18 - EVENT CANCELLATION OR POSTPONEMENT**

If, for reasons of force majeure, the Event should not take place, the amount paid at the time of registration will not be refunded, but the participation fee alone will be considered valid in the event of a request for registration for the following edition.

### ART. 19 - CHANGES

The Organisation reserves the right to make changes to the Regulations at any time. The web site <a href="https://www.gravelspluga.it">www.gravelspluga.it</a> is the only official information source of the Event. Therefore, all official communications will only be announced through it.



#### **ART. 20 - OTHER RULES**

For all matters not covered by these Regulations, the Event will apply the implementing rules of the current year's A.C.S.I. cycling amateur sector.

## ART. 21 - APPROVAL, CONSENT, AUTHORISATION, ETC.

By requesting to participate in Gravel Marathon Valle Spluga Family in any of the ways provided for in these Regulations, each participant from the moment of registration:

- Declares to have read and approved these Regulations and to accept each and every part of them.
- Acts as guarantor of his/her own behaviour during and after the Event.
- Declares to be in good physical condition and to have delivered to the Organisation a valid medical certificate after having undergone a medical examination for competitive cycling or cycle touring (as per article 6), providing the Organisation with the widest possible indemnity for any damage he/she may suffer because of his/her participation in the Event.
- He/she gives his/her consent to the use of his/her data, also for commercial purposes, in compliance with the provisions of the Personal Data Protection Code N. 196 of 30/06/2003 and the European Union Privacy Regulation 2017/679 (GDPR/18).
- He/she grants the Organisation the widest possible consent to use, in the ways permitted by law, including for profit, any of his/her video or photographic images taken during the Event, providing the Organisation with the right to transfer such images to third parties.

The aforementioned authorisation to use his/her image shall be understood to be granted for an indefinite period and without territorial limits throughout the world, for use in publications and various films, including, purely by way of example and without limitation, promotional and/or advertising materials produced on all media. The Organisation may also assign to third parties and to its institutional and commercial partners, the rights of use provided for in this agreement.

The Organisation declines all responsibility for itself and its staff, for accidents or damage to persons or property, which may occur before, during and after the Event or as a result thereof.

In addition, by submitting the online registration form, the participant self-certifies the non-existence of any sporting, civil and/or criminal sanctions, even if served, for doping-related facts and declares that he/she has not taken - and does not take - substances included in the World Anti-Doping Agency (WADA) anti-doping list <a href="http://list.wada-ama.org/prohibited-all-times/prohibited-substances/">http://list.wada-ama.org/prohibited-all-times/prohibited-substances/</a>

False self-certification will be prosecuted under the law.

In the event of a positive result in anti-doping controls carried out during Gravel Marathon Valle Spluga Family, or of a positive result ascertained within the following 6 (six) months in other sporting events, the rider shall pay Gravel Marathon Valle Spluga Family Organiser, as compensation for the serious damage caused to the image of the event, the sum of € 50,000.00 (fifty thousand/00 euros).

The sums that will be forfeited by the Organisation, as compensation for damage to image, will be entirely donated to youth sports activities.
